



## SUNY Cross Registration Billing Chart

This is meant to be used to assist campuses in determining what tuition and fees may be charged for cross-registration activity. It assumes that the student has registered at the Host campus and is active and matriculated, but not necessarily registered, at the Home campus for the term the student is cross registering.
